Therefore, if you do not receive a tax bill please contact the office at 378-6177, 378-6705, or 1-800-229-6177. Office hours are 8:00 a.m. to 4:00 p.m., Monday through Friday. An additional interest charge, set by the tax commissioner, will be added twice a year on unpaid delinquent taxes. The interest is charged on the first day of the month following the close of second half collection and again on December 1st.
